


Mapping of Richard Pierpoint's Land Grant







West Garafraxa Patent Plan



1877 Illustrated Historical Atlas (Walker and Miles 1877)




1861 Tremaine's Map of Wellington County (Leslie et al. 1861)



1906 Wellington Atlas (Historical Atlas Publishing Co. 1906)




1935 Topographic map, Guelph Sheet



Timeline of Events in Richard Pierpoint's Life



C. 1744: The man who would become known as Richard Pierpoint is born in the Bundu region of what is now Senegal.

1760: At 16 years of age, he is captured and enslaved, brought to America and sold to a colonial officer.

1780: Appears in the roster of the Butler's Rangers, fighting for the British in the American Revolutionary War.

1784: Named as a single man and "disbanded Ranger" for those men who would settle and cultivate the lands "opposite to [Fort] Niagara."

1786: Named in a "Victualling List" for Murray's District, which included part of St. Catharines.

1791: Granted 200 acres of land in Grantham Township (now St. Catharines).

1794: With 18 other Black men from the Niagara Region, sends a petition to Lieutenant-Governor John Graves Simcoe, requesting that they be granted land so they could build a settlement together, separate from White settlers. The petition is rejected.

1806: Sells his 200-acre grant in Grantham Township and purchases land in Louth Township.

1812-1815: At nearly 70 years of age, Pierpoint fights in the War of 1812 as a private in the Corps of Coloured Men. Pierpoint was the first to propose the creation of such a Corps.

1820: Presents a petition to Lieutenant Governor Maitland to request that he be sent back to his homeland in West Africa. The petition is ignored.

1822: The Garafraxa Township papers shows that the east half of Lot 6, Concession 1 is granted to Richard Pierpoint as a "Militia grant."

1825: Settlement duties on Pierpoint's property are completed.

1828: Pierpoint's will is written and witnessed by at least two men from Niagara.

1836: The abstract index to deeds shows the east half of Lot 6, Concession 1, containing 100 acres (40.47 ha) was patented by Richard Pierpoint on Sept. 22, 1836.

1838: This property was bequeathed by Pierpoint to Lemuel Brown. The will was registered on title in early October 1838.

1838: In November 1838, Brown sold Pierpoint's property in its entirety to Alexander Drysdale, a neighbouring Scottish farmer.

There is no exact record of Pierpoint's death.
